## Mt. Holly Springs Borough Council Meeting Minutes- April 13, 2020

**Call to Order –** Mr. Collins called the April meeting of the Borough Council to order at 7:00pm and led the Pledge of Allegiance.

## **New Business:**

Mrs. Neff made a motion to accept the granted extension for ATAK's subdivision plan through October 13, 2020. The motion was seconded by Mrs. Stoner and passed by unanimous vote.

Mrs. Boyles motioned to extend the Pension Plan RFP timeline for 30 days or until the emergency declaration has been lifted. The motion was seconded by Mrs. Neff and passed by unanimous vote. Borough Manager Day opened the sealed bids submitted to the borough office before 4 p.m. that day. Bids were submitted for the completion of a PennDOT paving project to be completed within the borough. Bids were received from EK Service in the amount of \$92,007.50, Hempt Brothers, Inc in the amount of \$91,872.50, Slusser Paving in the amount of \$101,024.00, and JVI in the amount of \$95, 700.00. Mrs. Boyles made a motion to award the 2020 paving project bid to Hempt Brothers, Inc. I the amount of \$91,872.00. The motion was seconded by Mrs. Stoner and passed by unanimous vote. Hempt Brothers, Inc. will be contacted upon confirmation from the Borough Solicitor.

**Adjourn** – Mrs. Neff made a motion to adjourn that was seconded by Mrs. Stoner. The motion passed unanimously. The meeting adjourned at 7:12 p.m.
